INSTITUTIONAL PROGRAM ACTIVITIES: MMC STUDENTS CAN PURSUE DEGREES IN 29 MAJOR PROGRAMS OF STUDY, CHOOSE FROM AMONG 40 MINORS AND PRE-PROFESSIONAL PROGRAMS, HOLD INTERNSHIPS AT RENOWNED NEW YORK CITY COMPANIES, ENGAGE IN SOPHISTICATED RESEARCH PROJECTS, STUDY ABROAD, AND PARTICIPATE IN SERVICE-LEARNING OPPORTUNITIES.
